2. This agreement creates a service obligation. If I accept payment for the language immersion program, program of study abroad, or academic course involving instruction in a foreign language of strategic importance to the Department of Defense upon contracting and fail to fulfill any part of my military service obligation (MSO) or active duty service obligation (ADSO, if applicable), outlined in my Army ROTC Contract, I will be required to reimburse the United States government through repayment of an amount of money, plus interest, equal to the entire amount of the bonus paid by the United States.
