SUBJECT: Cadet Summer Training (CST25) Policy Memorandum 31 - Requirements for Class 1A Flight Physicals at Cadet Summer Training

1. References:

- a. AR 40-501 (Standards of Medical Fitness).
- b. Aeromedical Policy Letters (APL) guide, https://aero.health.mil (updates regularly)
- 2. Purpose: To establish the minimum requirements for Cadets to receive flight physicals while attending Advanced Camp (AC).
- 3. Scope: These guidelines are applicable to all AC Cadets applying for a Class 1A Flight Physical to be conducted at CST.
- 4. Background: To ensure that Cadets most likely to branch into Aviation are able to receive Class 1A Flight Physicals administered at AC, and that the flight surgeons who support CST are effectively utilized, the below requirements were established. Professor of Military Science (PMS) should strictly monitor the Cadets who request a flight physical. It is imperative that PMSs do not routinely advise all Cadets to take a Class 1A flight physical. Given the high volume of flight physicals performed at AC, these requirements will remain in place.
- 5. Eligibility Requirements to take Class 1A flight physical at AC:
- a. Cadets must be in the current accession year group that will be considered for branching by the Department of The Army/Reserve Officer Training Corp Selection and Branching Board.
- b. Cadets enrolled in ROTC programs located more than 125 miles from the nearest medical treatment facilities and who have a Selection Instrument for Flight Training (SIFT) score of at least 40 may complete a Class 1A flight physical at AC. Exceptions will be considered and granted by the Command Surgeon, United States Army Cadet Command, on a case-by-case basis.
- c. Cadets must indicate the desire to branch Aviation by requesting Aviation in the top three active-duty branch preferences prior to the annual Selection and Branching Board. This requirement applies to out of cycle commissioning Cadets desiring Aviation,

provided they otherwise meet commissioning requirements.

- d. Basic Camp (BC) Cadets are not authorized a Class 1A flight physical.
- 6. Flight Training Qualification Tests.
- a. As of 1 January 2013, the only test that is accepted for branching into Aviation is the SIFT. The Accessions and Standards Division (ASD), Deputy Command Surgeon, G1, and USACC will only accept the SIFT score.
- b. Forty is the minimum qualifying SIFT score required to be eligible to receive a flight physical at AC.
- c. NLT 10 May 2025, the Cadet's SIFT score must be entered in the CCIMMS Training Module.
- 7. Flight Physical Request Memo:
- a. The PMS will complete a memo requesting a Class 1A Flight Physical at AC using the enclosed memorandum template.
- b. NLT 10 May 2025, the completed Flight Physical Request Memo and a copy of the SIFT score must be loaded into Cadet Command Information Module (CCIMM) under the document management tab.
- 8. Cadets who fail to meet any of the requirements listed in paragraph 4.a. will not be given a Class 1A Flight Physical at AC. Exceptions will be considered and granted by the Command Surgeon, USACC, on a case-by-case basis.
- 9.
