SUBJECT: Fort Knox Policy Memo #9 - Fort Knox Off-Limits Establishments/Areas

1. Reference Army Regulation (AR) 190-24 (Armed Forces Disciplinary Control Board and Off-Installation Liaison and Operations), paragraph 2-6.
2. The following areas/establishments are declared off-limits to Armed Forces personnel. The change in name of any of the establishments/areas does not revoke off-limits restrictions. The off-limits restriction for each establishment/area will remain in effect for an indefinite period.
 - a. Bluebird Properties, LLC; Bluebird Property Management, LLC; Affordable Investments, LLC; or any business owned and operated by Sharon Novak and/or Barry Risinger, 3223 South Dixie, Suites 3 & 4, Elizabethtown, KY 42701.
 - b. Jim Stanley Sr. Paving and Sealing INC; A-1 Paving Company INC; Jim Stanley Sr. Paving and Seal Coating; or any businesses owned and operated by Jim Stanley Sr. and/or Jim Stanley 256 High Water Road, Shepherdsville, KY 40165.
 - c. J&J Hardesty Farms, LLC; SPN Energy, LLC; Hardesty Farms Trucking, LLC; or any businesses owned and operated by Jim Hardesty and/or James Hardesty, 695 Miller Road, Guston KY, 40142.
3. Military personnel observed in off-limits establishments/areas are in violation of AR 190-24, and subject to apprehension and disciplinary action under the Uniformed Code of Military Justice (UCMJ).
4. Major subordinate commanders will ensure the contents of this memorandum are brought to the attention of all military personnel. A copy of the policy memorandum will be posted on all unit bulletin boards.
