SUBJECT: Cadet Summer Training (CST25) Policy Memorandum 36 – Temporary Duty (TDY) Cadre Curfew Policy

1. References.

- a. AR 600-20, Army Command Policy, 06 February 2025.
- b. Cadet Summer Training (CST) Policy Memorandum 16, Cadre Leaves, Passes, and Early Release, 03 June 2025.
- c. 2/3 CR Summer Training Off-Post Privilege Policy, 13 June 2025.
- d. 2/3 CR Cadet Summer Training Alcohol Policy, 07 June 2025.

2. Purpose: To establish an off-installation Curfew Policy for all TDY military personnel providing support for CST25.

3. Policy. All TDY military personnel, assigned, attached, or supporting CST, will comply with the provisions of this policy and other applicable regulations and directives.

4. General.

- a. An off-installation curfew is in effect from 2200 until 0600 EST, Monday through Sunday, including U.S. national holidays, and USACC training holidays.
- b. All TDY personnel supporting CST25 are required to return to post by 2200 EST unless they have an approved exception listed in paragraph 5.
- c. If TDY personnel are lodging off post while supporting CST25, these personnel must be in their place of lodging during the curfew period.
- c. All TDY personnel must inform their first line supervisor or chain of command if they will not be able to return to post or their authorized place of lodging by 2200 EST.
- d. TF CDRs have the authority to impose additional restrictions as required to maintain good order and discipline IAW the UCMJ and AR 600-20.

e. TF Rifles personnel will adhere to the 2/3 CR Cadet Summer Training Alcohol Policy and 2/3 CR Summer Training Off-Post Privilege Policy.

f. This policy exempts all Fort Knox permanent parties assigned, attached, or supporting CST that live on or off post.

5. Exceptions.

a. MWR activities. TDY personnel attending officially sanctioned MWR events off post shall be exempt from the curfew restriction. TDY personnel attending officially sanctioned MWR events must inform their first line supervisor or chain of command if they know or expect the event or activity will go past 2100 EST.

b. Command-authorized activities. TDY personnel attending command-authorized events and activities shall be exempt from the curfew restriction.

c. Leave and Pass. TDY personnel on authorized leave and pass are exempt from this policy.

d. Official Duty. Off post travel during curfew hours on official duty is exempt from the curfew restriction.

e. Emergency: Travel off post is authorized during the curfew restriction due to a legitimate emergency. If an emergency mandates travel off post, TDY personnel will, as soon as practical, inform their chain of command.

f. Waivers: TF CDRs, CoS, and DCOM may authorize individualized waivers that are consistent with the intent of this policy.
